Chambers and Partners announced its rankings for 2023. According to press releases received by Law Week, seven Colorado firms were recognized for their construction practice and attorneys. The ranking process involved interviewing the firm's clients and peers. "Construction covers contractual advisor work within the construction industry for both the suppliers, and those clients employing these types of companies on their building plans," notes Chambers and Partners on its website. Chambers and Partners is a legal research company that has been providing rankings for lawyers and law firms since its founding in 1989.

WOODS AITKEN LLP

Woods Aitken LLP announced it earned four practice area rankings as well as nine individual rankings, including Colorado for construction law attorneys Kory George and Joel Heusinger. George is a graduate of the University of Nebraska College of Law and Heusinger is a graduate of Duke University School of Law.

"Construction law is a unique practice area...it touches all aspects of a construction client's company," Heusinger wrote Law Week via email. The firm's construction team has been counseling clients since its founding in 1921. Both George and Heusinger counsel clients all over the construction industry, from general contractors to suppliers, assisting with "all stages of the construction process, from initial conversation to the resolution of disputes," George wrote Law Week via email.

With the future and uncharted opportunities on the horizon for construction law, George anticipates a dramatic increase in the use of AI technology "which should help to optimize efficiencies and reduce costs."

LEWIS ROCA

Lewis Roca Rothgerber Christie announced it earned 30 individual rankings and 13 practice area rankings including five individual rankings and two practice area rankings in Colorado. For construction, the firm said Chambers recognized Denver partner Ben Ochoa, a graduate of the University of Colorado Law School.

Ochoa has been part of the construction law practice group at Lewis Roca for over 35 years and even served as the chair. His experience expands across litigation, arbitration



and mediation for a broad range of construction disputes for clients who include construction lenders, owners and developers, special districts, contractors and design professionals.

"The Colorado market continues to get more and more sophisticated, and we expect to see continued increases in the size and complexity of projects around the state," Pray wrote to Law Week via email. "Parallel to that, we expect to see renewed interest in alternative delivery methods, such as design-build."

While Brownstein has seen a decline in new project work in the past year, Pray is hopeful this trend will reverse in 2024. He also hopes its practice will help lead market and statutory changes, as well as the large-scale conversion of office spaces into residential spaces for families.

Pray was also named in Colorado Super Lawyers 2023 and Walsh was recognized in Colorado Rising Stars 2023; both for construction litigation.
